#### **Technical Programme**

Topics will be presented by practitioners, judges and academics, with a focus on Financing and Insolvencies - with just enough academic and theoretical explanation, and an emphasis on the relevance for practitioners, from an economical and financial angle.

Topics to be discussed will include: Global Credit Risk Management, Shareholders as creditors, LMA Financing, Distressed Financing, Lender Liability, Estate Financing, Terminating of credit agreements and Credit Bidding.

Of course, the recast of the European Insolvency Regulation will be discussed as well. In 2017 this new regulation will come into force and what tips and tricks can we have in advance?
